PASSPORT NEWS

The official rules from the Department on Homeland Security (DHS) on passport use when traveling to and from Canada are a bit unclear regarding land travel. Air travelers are indeed required to produce a passport when crossing the Canadian/U.S. border. Land travel rules are in flux at this time. The DHS is determining just what documents will be necessary, and claim that their decision will be announced within 60 days of implementation. They do plan to announce and implement the land travel system during the summer of 2008. There is also discussion regarding alternative procedures for U.S. and Canadian children.

FAMILY TO RALLY AT EASTHAM

Eastham, Aug. 17.—The descendants of Deacon John Doane, who built the first dwelling in this town in 1635, and bought from the Indians all the land around Nauset harbor, will gather here Wednesday from all parts of the United States and Canada and dedicate a large boulder in the Town Cove Burial Ground. They will assemble first at the Shattuck House, Orleans, where dinner will be served, and then go to the Congregational Church to listen to an address of welcome by the Rev. H. A. Morton, pastor.

The exercises will be in charge of William Howard Doane, M. D., of Cincinnati. Professor Willard Doane of Salt Lake City, secretary to the Governor of Utah, will deliver an address on Deacon John Doane. The company will sing the Doane hymn "The Man We Honor," composed for this occasion by Dr. W. H. Doane. William Spray Doane of Indianapolis will speak on "The Pioneer Doanes of the Northwest Territory." Robert William Doane, of Toronto, will read a paper on "The Pioneer Doanes of Canada." "Pilgrims Compared with Other Colonists" will be treated by Benjamin H. Doane of New York city. Alfred J. Doane of New Jersey will expound on the topic, "The Future of the Family."

After the exercises, carriages will be taken to the Town Cove Burial Ground at Eastham, where a five-ton boulder will be dedicated.

This newspaper clipping from 1907 describes the dedication of the John Doane Memorial in Eastham. James Thomas Doane found this in a box containing his great-grandfather Prince Henry Doane's items.

DFA COLLECTIONS TO THE LIBRARY

In the next few months, the DFA archival collection held by Doane College in Crete, Nebraska will be moved from the historic 1883 Boswell Observatory building on campus where it has been kept since 1995. Space is being created for these items in the official Doane College archives in Perkins Library. The DFA collection at the college includes non-genealogical, miscellaneous files regarding Doane topics, copies of books written by authors who trace their lineage to Deacon John Doane, and books and articles about Doanes. The collection also contains several artifacts relating to DFA lines. Historian Katherine Blair maintains the genealogical records.

The present Doane College archival space is being reorganized, allowing room for the DFA collection to be moved into what will be a more convenient location. The collection is managed by Jacque Wisman of Crete in cooperation with DFA liaison Janet Jeffries of Doane College. The plan for the move was brought on in part due to Janet's recent transfer to the library staff where she will also be working with the Doane College archival collection. The DFA archives will be located in the same place as The Doane Family genealogical book inventory. Janet, and Janis Mitchell also of the Doane College library staff, manage the book inventory in cooperation with Linda Doane of Michigan, custodian of the books.

NEW ENGLAND DOANES IN THE US CENSUS

Thoughts and a Question

A quick inquiry on www.ancestry.com reveals that there were 937 individuals with the surname Doane enumerated in New England in the 1850 U.S. Census. In the 1930 U.S. Census, there were 941 individuals with the surname of Doane in New England. These numbers can be allocated to the six New England states as follows:

Enumerated in the 1860 U.S. Census in Washington County, in the State of Rhode Island, in the village of South Kingstown called "Peace Dale" was Felix Doane. Felix was a 30-year-old factory worker living with his wife Sarah and twin sons Edward and John. One of the interesting pieces of information with this enumeration is that Felix and his wife are stated as being born in Ireland. This family shows up in the 1880 census at Peace Dale with the additions of sons Charles, William, and Thomas. All the sons are stated as being born in Rhode Island, but the parents are again listed as being born in Ireland. Felix is again enumerated at South Kingston, Rhode Island in the 1900 U.S. Census. On this census he is listed as being a concrete contractor of unknown years, born in Ireland, married for 44 years, who came to the United States in 1854 and was by 1900 a U.S. citizen. He is living at this time with his wife Sarah and three sons, Edward, John, and Thomas. Is Felix Doane a descendant of our Deacon John Doane or did he come by the name independently?

DOANE FAMILY FOUNDATION SCHOLARSHIPS

In conjunction with Doane College, the Doane Family Foundation has established guidelines and an application for Doane Family Association members to apply for college assistance. We need you to know that a DFA member's child, or grandchild, will not necessarily receive priority assistance. Also, you need to know that your applicant does not have to attend Doane College to receive assistance. Funding of these scholarships by the Doane Family Foundation have in the past several years ranged from \$500 per year to \$5,000 per year. Average assistance has been in the range of \$1,500 per year. We usually give assistance to four or five students per year. We hope to increase our scholarship fund this year, which will enable us to increase our funding in the future. Please feel free to contact me if you have any questions regarding the process.

THE PROCESS:

- January 30 - Applicants submit the completed Doane Family Scholarship application and a copy of the current year's processed FAFSA results to the Doane Family scholarship organization.
- February 15 - Doane Family scholarship organization meets to review all scholarship applications and select potential recipients.
- February 25 - Doane Family scholarship organization submits to Doane College for consideration name(s) and recommended scholarship amount(s). Note: the final scholarship amount will be determined after May 1.
- May 15 - Doane College informs the Doane Family scholarship organization of its recipients (and financial aid awards), confirms with the recipient(s) their college choice, and requests copy of the recipient's final award notification.
- July/August - Check is cut by Doane College, made co-payable to the student and the college, upon receipt of a final award notification.

NOTES FROM MEMBERSHIP CHAIR

*DFA Payments must be US Funds**

DFA Treasurer, Barbara Doane, informed me that we can no longer accept foreign bank checks here in the United States as payment for DFA dues, etc. Our American banks hold the checks for fifteen (15) days, and then charge us fifteen dollars (\$15.00) for providing the collection service. I receive several Canadian and other international memberships in a year's time, and although most of them are accompanied by international money orders, a few have been checks. If you know of someone living outside the United States who will be sending in membership dues, please make them aware that the payment should be an international money order.

DOANE FAMILY FOUNDATION SCHOLARSHIP APPLICATION

Minimum Requirements:

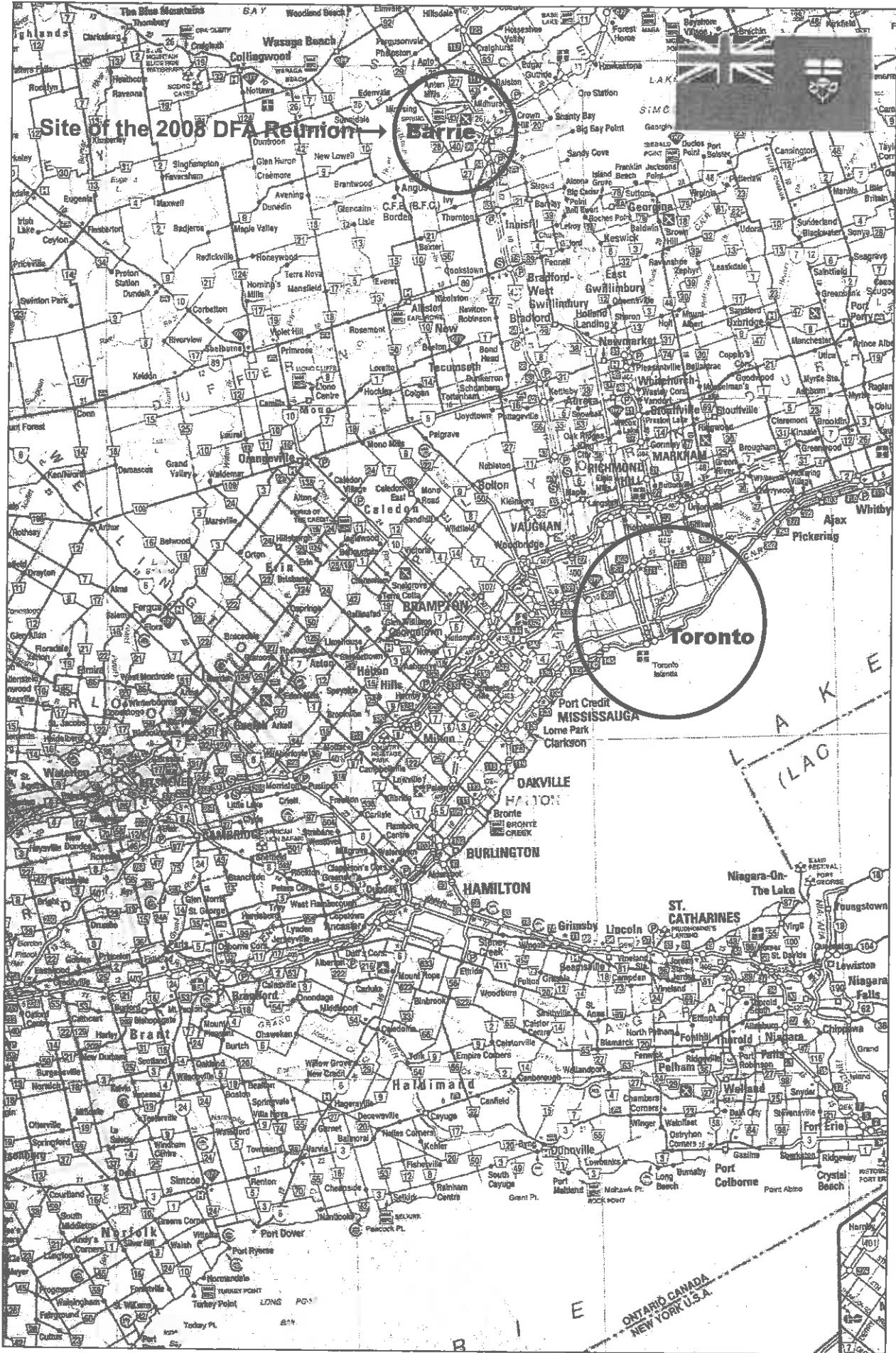
